

ORDINANCE NO. 2026-03

"ORDINANCE PROVIDING FOR THE BUDGET AND APPROPRIATIONS OF THE LA GRANGE PARK PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2026 AND ENDING JUNE 30, 2027."

WHEREAS, the Board of Library Trustees of the La Grange Park Public Library District, Cook County, Illinois, caused to be prepared in tentative form a Budget and the Secretary of this Board has made the same conveniently available to public inspection for at least 30 days prior to final acting thereof, and

WHEREAS, a public hearing was held as to such Budget on the 16th day of September, 2026 and notice of such hearing was given at least 30 days prior thereto as required by law, and all other legal requirements have been complied with.

NOW THEREFORE, Be it Ordained by the Board of Library Trustees of the La Grange Park Public Library District, Cook County, Illinois, as follows:

Section 1: That the fiscal year of this Public Library District is hereby fixed to begin on July 1, 2026, and end on June 30, 2027.

Section 2: That the following Budget containing an estimate of the amount available and expenditures and the appropriations contained therein be and the same is hereby adopted as the Budget and Appropriations for this Public Library District for this fiscal year and the sum of **\$2,887,980.00** or as much thereof as may be authorized by law, is hereby appropriated for the purposes of the La Grange Park Public Library District, hereinafter specified for said fiscal year.

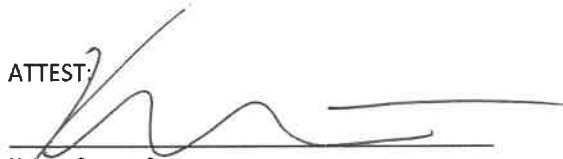

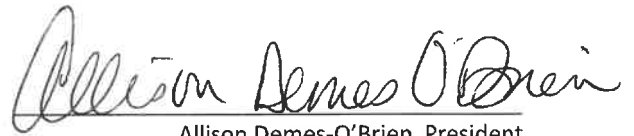
